**NOTICE INVITING TENDER FOR SALE OF SEEDED TAMARIND - 2019 CROP**

The Managing Director, Tribal Development Cooperative Corporation of Odisha Limited, Bhubaneswar invites Tenders in prescribed form to be received up to 12.00 P.M. on 31.08.2019 from the reputed firms/companies/bidders of State of Odisha and outside for disposal of 1112.28 Quintals of SEEDED TAMARIND 2019 crop procured under MSP Scheme by tendering process. The commodity offered will be delivered from different storage points under different Branches of TDCCOL as given below.

1. Tender is to be submitted in a sealed cover duly subscribed with "Tender for SEEDED TAMARIND - 2019 Crop and addressed to the Managing Director, Near Rupali Square, PO. Bhoi Nagar, Bhubaneswar-751022, so as to reach in the above Office up to 12 P.M. of 31/08/2019.
2. The acceptance of tender shall be subject to final decision of the Managing Director, TDCCOL.
3. Earnest Money Deposit/ Tender Security of Rs. 25,000.00 (Rupees Twenty five Thousand) only in shape of Demand Draft favouring the "Managing Director",TDCC, payable at Bhubaneswar from any nationalized bank has to be submitted along with the tender documents.
4. Tenders received shall be opened at 01.00 PM on 31 .08.2019 in the office of the Managing Director, TDCCOL, Bhubaneswar, Odisha in the presence of the Tenderers or their authorized representatives.
5. If the office happens to be closed on the last date of opening of the Tenders as specified, the Tenders will be opened on the next working day at the same time and venue.
6. The submission of tender for this purpose shall be taken as sufficient proof for acceptance of all the terms and conditions of tender by the Tenderer herein contained, which shall be binding on him.
7. Tribal Development Cooperative Corporation of Odisha Ltd is not bound to accept the offer and also reserves the right to reject any or all the offers submitted for such purchase of SEEDED TAMARIND without assigning any reason thereof.
8. Each offer / tender shall contain the full name and address of the tenderer and the person signing the tender should give his full name and specify his status and capacity in relation to tenderer.
9. The tenderer shall quote the rate on ex godown delivery basis **exclusive of all taxes, duties, levies, fees etc.**

10. The offer of the Tenderer shall remain valid for a period of 45 (forty five) days from the date of opening of the tender for acceptance.
11. The successful Tenderer shall be required to furnish in advance the entire bid value in favour of Managing Director, TDCCOL payable at Bhubaneswar, which is 100% of the value of the allotted stock (including EMD) within 7 days of receipt of the intimation/acceptance order. In addition to sale value, the purchaser has to deposit the required GST on sale value as applicable.
12. No complaint (s) regarding quantity and quality of the stock shall be entertained subsequently after allotment nor shall TDCCOL be responsible for any deterioration due to delay that may take place in course of dispatch / lifting or purchased goods by the purchaser. Further, the successful tenderer(s) shall be allowed a maximum period of fifteen days from the date of sale order for lifting of the stock.
13. Mode of delivery being Ex-Go down, all charges for weighing and bagging of the stock at the time of delivery and loading of the goods in truck etc. shall be borne by the purchaser.
14. The purchaser has to deposit the cost of gunny bags on actual basis in the respective branches with due acknowledgement. In case the party lift the stock with own gunny bags then the cost of gunny will be exempted.
15. Before taking delivery of the goods in case the purchaser (Manufacturer) is unable to submit necessary certificate in Form No.27C as per Rule 37C under Income Tax Act, valid for the period of agreement made with him, Income Tax at the prevailing rate along with surcharge, if any will be collected at source U/s 206 C of the I.T.Act as applicable under the law and will be deposited with the Central Government at the credit of the buyer within next seven days & a Tax deduction certificate will be issued to buyer in Form No.27 D Under Rule-37 of the said Act.
16. Any contract by the successful tenderer with any third party in respect of the sold stock will have no bearing on TDCCOL.
17. Delivery of the stock for SEEDED TAMARIND will be given on “AS IS WHERE IS BASIS’ and no selection / rejection shall be permitted.
18. Quantity offered for purchase of SEEDED TAMARIND is approximate. The TDCCOL will not be responsible if they fail to make available the quantity offered in the tender notice.
19. The Courts at Bhubaneswar only will have the jurisdiction to adjudicate disputes arising out of this contract and no litigation of any nature shall be instituted by the parties in any other court.
20. The Tribal Development Cooperative Corporation of Odisha Ltd reserves it’s right to negotiate with highest Tenderer or any other Tenderer after opening of this tender for SEEDED TAMARIND.
21. The party should be a registered dealer.
